The combination of workers returning to their EU home countries or seeking alternative employment, as well as the day-to-day Covid health challenges of illness and self-isolation, has caused major disruption for the night time economy.

Both at IPSA and within the company we will be focused on pushing for an industry wide shift to uplift pay and charge rates, which is fundamental to creating long-term stability and viability for the sector.

The SIA are bringing in new training requirements from 01 October 2021 if you are renewing your frontline licence. Don't get caught out and risk being stood down for not having a valid licence if you are renewing your Door Supervisor or Manned Guarding licence on or after 01 October
