Scope of this privacy policy

How we collect Data

- 6. We collect Data in the following ways:

 - b. Data is received from other sources; and
 - c. Data is collected automatically.

Data that is given to us by you

- 7. The International Professional Security Association (IPSA) will collect your Data in a number of ways, for example:
 - a. When you contact us through the Website, by telephone, post, e-mail or through any other means;
 - b. When you register with us and set up an account to receive our products/services;
 - c. When you complete surveys that we use for research purposes (although you are not obliged to respond to them);
 - d. When you use our services;

in each case, in accordance with this privacy policy.

Data that is received from third parties

Data that is collected automatically

- 9. To the extent that you access the Website, we will collect your Data automatically, for example:

Your rights
